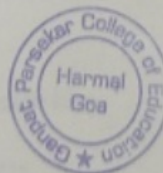
MEMORANDUM OF UNDERSTANDING

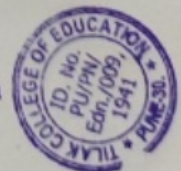

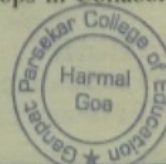

AND WHEREAS

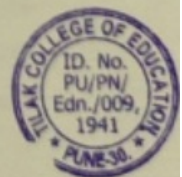
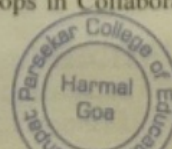
Both the parties herein have arrived at the modalities and agreed to document operative modalities, mutual responsibilities and obligations for these activities through this Memorandum of Understanding.

In order to carry out and fulfil the aims of this MOU, each party shall identify a contact person to coordinate the development of each endeavour and conduct joint activities.

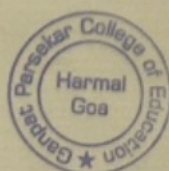
8. Revision, Variation and Amendment –
