Education, respectively. After the funds are received from the funding institutions, Tilak College of Education will reimburse the entire expenses incurred by MIT ADT University.

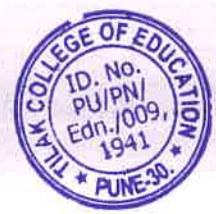
Both the parties also agree for the **student exchange program** where students can visit the institutes for projects, seminars or internships as per their needs.

Both parties have also agreed to collaborate with each other for the use of the **Psychology Laboratory** i.e. the test procured by the institutes could be shared with each other only after the permission & signed letter which states to use the test without damaging any of them. In case there is any kind of damage found then the respective institute has to bear the cost to the other institute.

Both parties also wish to collaborate with us for the **outreach programs**. MIT SOER is already undergoing outreach activities under 'SAKSHAM' & has collaborated with Idea & Janaseva Foundation so the collaborations will be in the name of MIT SOER only but the programs can be organized by both the institutes. So both the parties will jointly conduct programs for them and students will be exchanged from both the institutes to work under these outreach programs.

Both parties agree to actively **promote each other's programs and activities** of mutual interest to students, faculty, other members of the institution and general community.





Both the parties agree that **intellectual property rights** of the course design, course structure, course content, pattern of teaching & examination which are designed and developed by either party, shall be fully owned by that party.

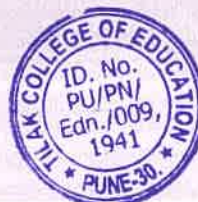
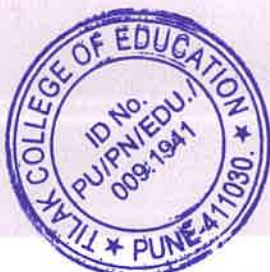
